### General Information:

The Central Texas Football Chapter provides trained and qualified football officials to the Central Texas Area Middle and High Schools.

Our chapter is a proud member of the Texas Association of Sports Officials (TASO), governed by a Constitution and By-Laws and an elected Board of Directors. Board meetings are held in the off-season, general membership meetings are held during the season and annual dues are collected from all the members. Officials are grouped by divisions one through five (one being the highest) based on their experience level. Established crew chiefs are approved by the board of directors.

### Coaches Information:

On behalf of the entire Board of Directors (BOD), we extend our sincerest appreciation to any school that takes interest in using our chapter to provide officials for their home schedule. Questions regarding the operation of the chapter or the assigning of officials should be directed to either the President or Assignment Secretary (contact information listed on the next page). We meet with coaches at the beginning of every school year to address any topics coaches or school administration may have.

### Membership in the Chapter:

Anyone who is interested in becoming a football official must be at least 18 years of age and NOT have been convicted of a felony or have any criminal charges pending. A membership application, accompanied by annual dues is required and authorization to initiate a criminal record's check.

Applicants can apply for membership by downloading the membership application form found on our chapter website and submitting it in person or via email to the Treasurer (contact information listed on next page).

### Recruitment Information:

We look for individuals who enjoy sports, are energetic, and enjoy being outdoors in the great Texas sunshine. We also look for individuals who can be a mentor to our youth.

Our extensive new-official mandatory training program is designed to prepare officials who are just starting out or have very little experience officiating High School Football.
